
Additionally, suggest to add following conditions under "Technical Capacity"

1. Bidder must not have suffered bankruptcy/insolvency proceedings during the immediately preceding five years.

2. The bidder should submit an undertaking to this effect as part of the Technical bid.

3. Any subsidiary of which the parent company has been blacklisted under the insolvency and Bankruptcy code would not be allowed to participate in the Tender.
